1. What Information Does I.Q. Data Gather?

<u>Information You Give Us.</u> We may collect and retain any information provided by you or gathered from your devices in connection with your online activity. For example, we collect information you give us when you

- use our service or download materials from our Site;
- pay your account or engage in other transactions with us;
- communicate with us, such as to provide feedback, complete an online survey, request support or service, or ask for additional information;
- register for or manage an account with us; or
- subscribe to newsletters, email lists or other content we provide.

We may collect information such as your first and last name, home or other physical address, email address, zip code, telephone number, other information that permits you to be contacted physically or online, or information about your interactions with us or others, and other information. In connection with certain activities on our Site (e.g., making a payment) you may provide us information such as payment card information, bank account information, social security number, or driver's license number.
